
CONCERVANCIES IN THE EDUCATIONAL ENVIRONMENT

WHO MUST BE INVOLVED?

- Personnel of the institution
- The students of the institution.
- The governing body of the institution.
- The Department of Environmental Affairs.

WHAT IS THE PURPOSE OF AN EDUCATIONAL CONSERVANCY?

To manage the direct environment of the institution and to create a healthy clean and sustainable environment for the students to educate themselves in, not only

academically, but to create an environmental conscious to manage the environment sustainable.

HOW DO WE ESTABLISH AN EDUCATIONAL CONSERVANCY?

- Arrange a meeting between the governing body, teachers, student leaders and the Department of Environmental Affairs, and the local Educational Departments representative
- This meeting will be addressed by an official of Environmental Affairs on the forming of a conservancy.
- Elect a conservancy committee
- Draft a constitution.(in this constitution the objectives and goals will be set)
- Name the conservancy.
- Identify the other stakeholders that can help to create the environment where teachers and students can perform to there best.

THEY WAY FORWARD IN THE EDUCATIONAL CONSERVANCY

The committee of this conservancy must have regular meetings to discuss the management of the schoolyard and to arrange actions like environmental quiz between the different grades and the parents as well. Introduce the school environmental policy pack. Encourage the school to establish an enviro-club. Doing this, it will not only encourage the learners to upgrade the school environment but it will blow over to the community as well. These actions can be promoted by anybody and the environmental educators can implement this in the different schools.

- Draw up a constitution for the conservancy.
- Manage the institution's environment.
- Plan activities.
- Workshop teachers on the environment.
- Workshop students on the environment.
- Let the different classes draw a diagramme of the school, on the diagramme indicate the problem areas; indicate where what can be done.
- Establish an environmental club.
